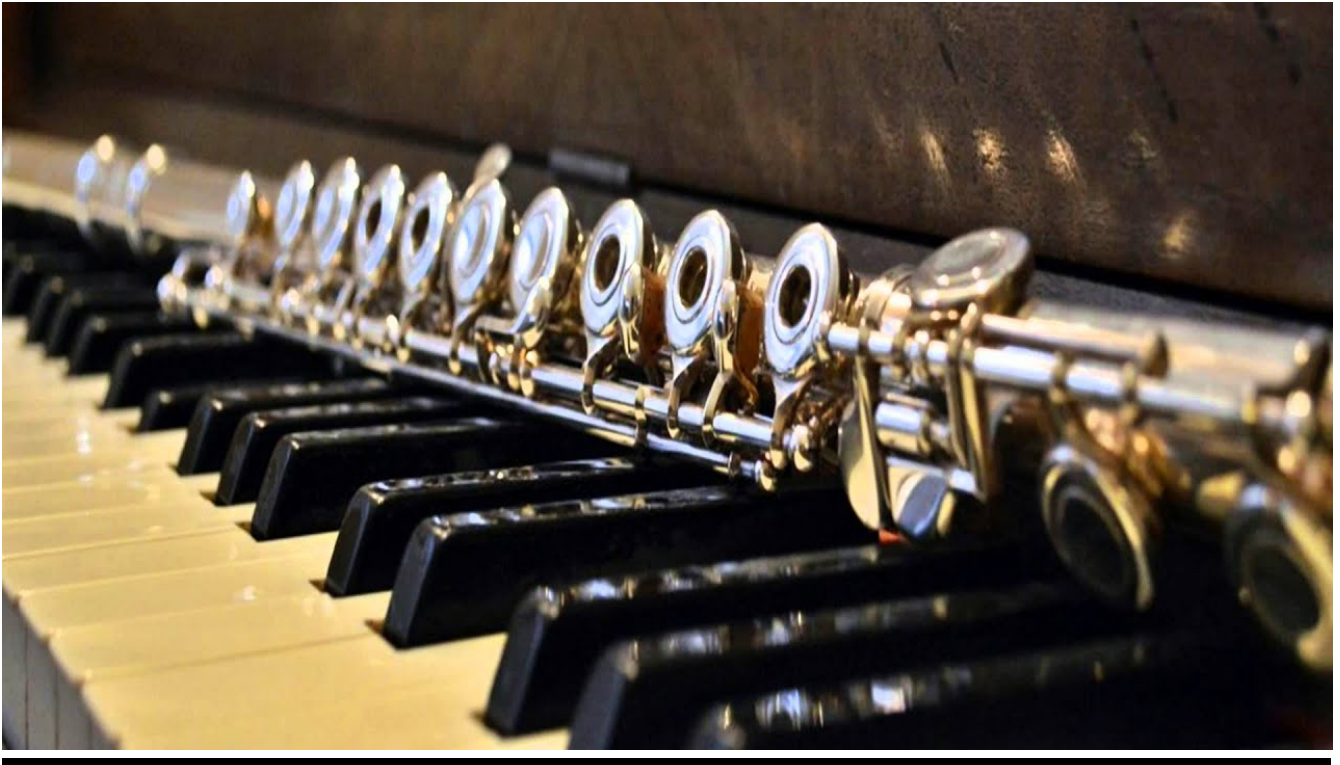

GCMTA GOLD CUP INCENTIVE AWARDS

Students of GCMTA teachers who participate in GCMTA performance events are able to accrue points toward these cups. A plaque is awarded to students reaching 200 points. **Teachers contribute \$5 for each student's award to allay the cost of these beautiful cups. Orders are placed by chair April 1 and June 1.**

TEACHERS ARE ENCOURAGED TO PARTICIPATE IN THIS BEAUTIFUL AND ACHIEVABLE AWARD. TO DO SO, TEACHERS MUST FILL OUT THE GOLD CUP FORM FOR EACH EVENT FOR STUDENTS TO RECEIVE THE POINTS.

Two points will be awarded for playing in non-adjudicated events (recitals, festivals, outreach recitals). Six points will be awarded for playing in a Master Class, with two points awarded for auditing the class. Five points will be awarded for taking the MSMTA High School Piano Recognition/Credit examination regardless of grade.

One point will be awarded for taking the MSMTA Theory Exam with a score of 70 or higher.

One point will be awarded for taking the MSMTA Keyboard Exam with 4 or more modules Satisfactory or higher.

For all other adjudicated events, points will be award on the following scale:

Superior +	8	Excellent +	5	Good and below	2

The Gold Cup Chair records points for participating students. Awards are purchased each year in April and again in Mid-May for presentation at year-end recitals. Students who participate in several events should be able to earn their first cup within 3 years. Points stay with the student, and are transferable if a student changes teachers to another GCMTA teacher. The cups have an engraved brass plate.

The "Gold Cup Entry Form" in this handbook clarifies how to submit entries for each event.

GUIDELINES FOR STUDENT RECITALS, JUDGED RECITAL & FESTIVALS

1. Use Recital Slips for Recitals, Judged Recitals and Festivals.
2. All deadlines are IN HAND deadlines.
3. Use the students' recital guidelines listed below.
4. Judged Recital has a time limit of 2 minutes minimum and 8 minutes maximum.
5. For Outreach Recital expectations, see the Outreach Recital page (p. 11)

Fees for Recitals and Festivals

Theme Festival a fee of \$12 will be charged per participant.

Friends and Family a fee of \$15 per group.

A fee of \$20 per person will be charged for the Judged Recital (each player is limited to three performances in the Judged Recital).

A fee of \$20 per entrant for the Piano Solo Competition, and \$40 for the High School Award.

RECITAL GUIDELINES

1. Teachers prepare a separate recital slip for each performer, using photocopies of the sample recital form in this handbook. Please list composers' first name or initial and last name.
2. Adhere to deadlines, and submit the entry forms in the format preferred by the chair (shown on the forms). E-mail the chair to confirm that you have mailed your forms.
3. Performers should arrive 10-15 minutes prior to the performance and report to the chair.
4. Solo pianists are required to perform from memory in GCMTA recitals. Memory is optional for other performers, i.e. piano ensemble or instrumentalists. No photocopies.
5. Recital etiquette is the responsibility of the teacher. Please inform parents and students about:
 - (a) bowing
 - (b) remaining silent during the performance
 - (c) staying until the end of the recital (required to receive Gold Cup Points)
 - (d) leaving and returning during the recital to use a rest room between performances.
 - (e) refraining from using flash cameras during the recital (video cameras are permitted to tape one's own students, but one must have permission from the family to tape another student)
 - (f) leaving small children and babies at home.
6. It is recommended that teachers be in attendance when their students are performing to handle any problems. Teachers who must be absent should arrange for another adult to handle any problems that might arise.
7. Any special requests, such as early or late recital times, should be noted on the entry forms. The chair will try to honor the request, but is under no obligation to do so.
8. Chairperson has the discretion as to playing order; however, draft programs will go out before the event, and participating teachers must contact the chair within 24 hour of receiving the draft to request any changes including playing order.

GUIDELINES FOR COMPETITIONS

1. The Spring Piano and High School Award Competitions shall be open to the public.
2. All entry forms must be filled out completely and signed by the teacher and parent before the students will be entered. Fees for each event must be turned in by the teachers with a single check. Do not turn in individual checks or cash from the parents. All deadlines are to be honored as the chair requests.
3. Literature may be changed provided the literature conforms to competition requirements and does not exceed the original estimated time. The chair must be notified six days in advance and there will be a \$2.00 late fee per student. **Exact timings are necessary for each piece to allow for the scheduling of judges.** Teachers are responsible for accuracy and completeness of application forms.
4. Music should be in original form. No arrangements or abbreviations of classics may be used. Concert transcriptions such as Bach/Hess "Jesu, Joy of Man's Desiring" may be used with clearance from the chair. The chair of the event is responsible for determining if the literature is appropriate for the event. The decision of the chair is final.
5. All piano music must be memorized except for complicated avant-garde compositions which need to be cleared with the chair. No photocopies.
6. Judges' decisions are final. Criteria for judging is a "polished artistic performance."
7. Teachers may accompany their own students.
8. Teachers should avoid speaking to judges until the close of the judging day. Problems should be referred to the monitor or the chair. Teachers should not sit with, talk to, or acknowledge in any way students or parents until after the announcement of winners.
9. Teachers must be available to monitor at the competition, and are responsible for picking up critiques, certificates and plaques after the competitions. Because of expense, none will be mailed.
10. Students must bring a copy of the music for the judges. Neither the student's, parent's nor teacher's name should be visible on the music provided to the judge. We require the teachers and students to honor the copyright laws – photocopied music for judges is NOT ALLOWED.
11. Please read your e-mail for any updates or changes.
12. Students may enter any event non-competitively for a critique.
13. There will be a time limit of eight minutes for students age 11 and under, and twelve minutes for those 12 and above.
14. First place winners may enter only non-competitively the following year.
15. **Note: Students who will not be present for the entire "recital" will be allowed to play and will receive their critique (as applicable) but will not be eligible for an award.**

STUDENT AND PARENT INFORMATION

The Greater Columbia Music Teachers Association (GCMTA) welcomes students and their families and friends to the new school year of recitals, festivals, and competitions. We want our events to be a source of enjoyment for all who attend.

Please observe the following:

1. No food, drinks, gum, crayons, coloring books, magic markers, felt tip pens or electric games may be brought into the performance space. Cell phones and beepers must be silenced.
2. No pictures should be taken during an event. Video recordings are acceptable because they do not use flash, but please prepare your equipment before the event begins and video only your own child. Flash pictures may be taken after the recital.
3. Children may not play with toys on the floor because it is a distraction.
4. It is distracting for performing students when young children and babies are out of control. If younger siblings cannot be contained they should be left at home. Please take children out if there is a problem during the event. Generally children under six should not attend public performances.
5. Parents are asked to supervise younger children at all times, ensuring their safety as well as respect for the property. When younger children use the restroom, please have an adult in attendance.
6. If you must leave the performance area for any reason, please do so between performances.
7. Performers should arrive 15 minutes prior to starting time and report directly to the chair or monitor.
8. Performers should dress nicely. Casual dress (jeans, shorts, T shirts) is not appropriate.
9. GCMTA recitals are generally scheduled to be less than one hour in length. Please remain for the duration of the recital. All students deserve a full audience.
10. The performing order of students will not be changed once the programs have been typed. Please do not ask to play first to leave early.
11. Students should bow after performing, to acknowledge applause.
12. **Students who will not be present for the entire recital will be allowed to play and will receive their critique (as applicable) but will not be eligible for Gold Cup points.**

MSMTA HIGH SCHOOL PERFORMANCE AWARD

This event is open to performers on any instrument who are studying that instrument with a GCMTA Member. **The chair needs an estimate of student participation by school grade and instrument by February 24th, 2026.**

Maryland State Music Teachers Association provides a \$100 award to each local association for a competitive performance award. MSMTA rules state that an individual may only win a MSMTA performance award once. *Thus, if a student wins the award in one local association, they are not eligible to win it in another local association.*

In GCMTA the MSMTA award is given to the highest ranked performer in the High School Performance Competition. A previous MSMTA winner from any local association cannot participate in the GCMTA High School Performance Award.

The MSMTA award is given in lieu of the normal GCMTA award so the First Place Winner would receive the \$100 award from MSMTA instead of from GCMTA.

Please note that the First Place winner in the GCMTA High School Performance Competition is not eligible to compete again.

Any student not winning First Place in the GCMTA High School Performance Competition should have the opportunity to strive for that honor in future years.

There is no cash prize awarded for Honorable Mention: however ties will be allowed for Honorable Mentions.

This event is held in audition format.

The public is invited; however the teacher may not be present while their students are performing.

GREATER COLUMBIA MUSIC TEACHER'S ASSOCIATION

BYLAWS

ARTICLE I-OBJECTIVES

This association is an educational, nonprofit organization. The Greater Columbia Music Teachers Association does not discriminate on the basis of race, color, sex, religion, sexual orientation, national or ethnic origin, age, disability, or veteran status with regard to membership or participation in any program or activity administered by the association.

The purposes for which it is formed are as follows:

To foster a spirit of assistance, cooperation and sharing between teachers, students and parents of students with the intent of increasing the joy and pleasure derived from music listening, music teaching, music learning and music making.

1. To provide activities to assist all students and teachers in their musical and personal growth.
2. To further the activities and goals of the Maryland State Music Teachers Association (MSMTA) and adhere to the guidelines in the MSMTA Bylaws.
3. To cooperate with all worthwhile musical organizations, and to develop a close affiliation with the Music Teachers National Association and the Maryland State Music Teachers Association.
4. To raise funds for carrying out the purposes set forth herein, and for conducting the Association's business.
5. GCMTA is not organized for profit and no part of its net earning inures to the benefit of any private individual.
6. In the event of the dissolution of this organization, any fund remaining in the treasury after the payment of any outstanding debts shall be contributed to a nonprofit organization which qualifies under Section 501(c)(3) of the Internal Revenue Service Code.

ARTICLE II-MEMBERSHIP

SECTION 1. Membership is open to all members of MSMTA interested in supporting the objectives of this association and shall consist of the following classifications: a) Active b) Prelude c) Provisional d) Life e) Patron f) Student

SECTION 2. Active membership shall be open to teachers of music in any of the various musical fields. All applications shall be in

writing on a form provided for that purpose. The applicant must supply name, “contact information” – address, telephone number(s), and e-mail address, musical subjects taught, professional qualifications and additional training. Each applicant must be sponsored by two active members in good standing.

SECTION 3. ACTIVE MEMBERSHIP Active members shall have the right to vote, hold office and have their students participate in GCMTA events. Active members maintain themselves in “good standing” by attending one general membership meeting and entering students in at least two GCMTA events during a fiscal year.

SECTION 4. PRELUDE MEMBERSHIP “Prelude Members” are members who joined through MTNA or MSMTA without doing the full GCMTA membership procedure. Prelude members may enter students in GCMTA and MSMTA events but may not vote on GCMTA decisions or hold office. Prelude members will have 2 years in which to get signatures from two currently active members as in Section 3, allowing them to hold fully active GCMTA membership.

SECTION 5. PROVISIONAL MEMBERSHIP Provisional membership shall be extended to prospective members holding Provisional Membership in MSMTA and who are working to meet the requirements of Active Membership in MSMTA and GCMTA. They may not hold office nor may their students participate in “GCMTA” Competitive activities. They may not advertise themselves as members of GCMTA, nor will they be listed in the Directory until they have met the requirements for Active Membership. Provisional membership shall have a maximum length of five years and shall not be renewable.

SECTION 6. LIFE MEMBERSHIP Life membership shall be granted to any active or associate member upon payment of an amount fifteen times that of the annual GCMTA dues any time during the membership in the Local Association. There shall be no further dues paid to the Local Association.

SECTION 7. PATRONS Individuals or corporations, giving \$500 or more to the general funds of the Association or for special projects, shall be designated “Patrons” of the GCMTA. Patrons shall be nonvoting members.

SECTION 8. STUDENT MEMBERSHIP Student membership is open to any qualified music student subject to state membership regulations. A student of music is defined as a person who is currently involved in music study or is a participant in a music organization. Such a student is not required to be a music major. Age limit is through 26 years of age. Such membership provides the American Music Teachers magazine, the MSMTA newsletter, all GCMTA literature, and admission to all programs of the Association upon payment of the registration fee, but does not include the right to vote, to hold office, to enter students in auditions or to apply for certification.

SECTION 9. TERMINATION OF MEMBERSHIP–SUSPENSION–EXPULSION

1. Membership in GCMTA may be terminated or suspended voluntarily by any member by sending a letter of withdrawal to the President of GCMTA, which action shall be effective as to the date the withdrawal letter is received by the President.
2. Membership in the Association may be terminated or suspended involuntarily due to:
 - a) failure to meet the requirements for membership in the Music Teacher’s National Association.
 - b) good causes, which shall consist of any act in violation of the GCMTA’s Articles of incorporation; a criminal conviction or a finding of civil liability for any act of offence involving moral turpitude and other conduct detrimental to the best interest of the Association.
3. Any member shall be suspended or expelled by a three – quarters vote of the Executive Board.

4. Any member whose membership is affected by dismissal by the Board shall be notified in writing of the impending process for dismissal and be given the opportunity to meet with the board accompanied by a mentor or sponsor to speak in his/her behalf. The written notification of dismissal shall contain detailed cause for the dismissal decision by the board.

ARTICLE III-OFFICERS

SECTION 1. The officers of GCMTA shall be a President, Vice President, Secretary and Treasurer.

SECTION 2. All officers shall hold offices for two years, or until their successors are elected. However for the initial term only, the vice president and the secretary will serve a one year term only. Subsequently these offices will be filled every two years. No officers except the Treasurer shall serve more than two consecutive terms in the same office.

SECTION 3. The **PRESIDENT** shall be the chief of the Association; shall preside at all meetings of the Association and the Board of Directors; shall be ex-officio a member of all committees, and appoint chairmen of all committees subject to the approval of the membership.

SECTION 4. The **VICE PRESIDENT** shall assist the President of the Association and, in the absence of the President, shall assume the President's duties.

SECTION 5. The **SECRETARY** shall keep a record of attendance and minutes of proceedings of all business meetings and Board of Directors meetings; and shall handle general correspondence, including notices of meeting and functions.

SECTION 6. The **TREASURER** shall perform all duties pertaining to the finances of the Association.

SECTION 7. ABSENCE FROM DUTY. An officer of GCMTA who may for any cause be unable to fulfill the duties of the office shall without delay notify the President in writing. In the case of an emergency, this notice may be given to the President or Secretary by the most expeditious means.

ARTICLE IV–BOARD OF DIRECTORS

SECTION 1. COMPOSITION. There shall be a Board of Directors consisting of four officers, the immediate past President and all committee chairmen.

SECTION 2. Except in the initial year of existence, no member shall be eligible for office who has not been a member of the Association for one year.

SECTION 3. In case of a vacancy in office for any cause, the Board of Directors shall have the power to fill said vacancy until the next regular election, subject to approval of the general membership at the next general business meeting.

ARTICLE V–MEETINGS

SECTION 1. At least one meeting will be held annually by the Board of Directors.

SECTION 2. At least one general business meeting open to the entire membership will be held annually.

SECTION 3. All other meetings will be held at the discretion of the entire membership.

ARTICLE VI – ELECTION OF OFFICERS

The election of officers shall proceed in the following manner:

1. A Nominating Committee, consisting of at least 2 members, will be appointed in January to propose a slate of officers to fill open positions.
2. The Nominating Committee will be ready to announce the proposed slate at the May meeting. Additions from the floor will be accepted with the consent of the nominee. Ballots will be promptly mailed to the entire membership.

3. Write in nominations will be accepted as long as the nominee has agreed to serve. All ballots must be postmarked by May 25th and sent to the Secretary to be counted. A majority vote of the returned ballots is necessary for election.
4. New officers will be installed at the June meeting.

ARTICLE VII-DUES

SECTION 1. The membership fiscal year shall be from July 1 to June 30.

SECTION 2. Annual dues shall be set by the Board of Directors subject to membership approval as follows:

- a) All members will be notified in writing of the proposal.
- b) A ballot and postmark deadline for returning the ballot will be included in the notification.
- c) A majority of the votes received will pass the proposal. Music Teachers National Association (MTNA) and MSMTA memberships are required of all GCMTA members and dues, as set by MTNA and MSMTA, are payable with GCMTA dues to the National Treasurer of MTNA.

SECTION 3. GCMTA may provide additional monies for its own use.

SECTION 4. Dues must be paid in accordance with MTNA regulations to retain membership in GCMTA.

SECTION 5. If a member in good standing should withdraw his membership, he may be reinstated upon payment of the dues of the current year.

ARTICLE VIII – QUORUM

SECTION 1. One more than twenty percent of the active membership shall constitute a quorum for the transaction of general business.

SECTION 2. The membership may be polled by mail at the discretion of the Board of Directors by the majority vote at a general business meeting.

ARTICLE IX-PARLIAMENTARY AUTHORITY

The rules contained in “Robert’s Rules of Order Newly Revised” shall govern this Association in all cases to which they are applicable, and in which they are not inconsistent with the Bylaws of the Association.

ARTICLE X- AMENDMENTS

These Bylaws may be amended by written ballot by a two-thirds vote of the entire membership, provided that notice of the proposed amendment has been sent to the entire membership along with the ballot.

CODE OF ETHICS

1. GCMTA members shall maintain professional standards by entering only well prepared students in any GCMTA event.
2. GCMTA members should speak and act in a professional manner in regard to other colleagues and other students at student activities.
3. As GCMTA is a professional group, all comments of a personal nature should be avoided. Members shall act with integrity and kindness in regard to colleagues in their professional abilities in their field of teaching and performing.
4. GCMTA members shall maintain their professional abilities in their fields of teaching and performing.
